CUPRO-NICKEL, 10% (CDA 706) "HIGH PURITY"

(In cooperation with the American Society for Testing and Materials)

This material is in the form of small granules prepared by water atomization and is intended for use in chemical and instrumental methods of analysis. A similar material, SRM 875, Cupro-Nickel, 10% (CDA 706) "Doped", also is available having a somewhat different composition, especially for the trace elements of importance.
